8. How would you handle the children going to school in the morning in the event the court grants you custody?
9. How is it handled at the present time?
10. Do you have flexibility in your employment in the event the children become ill or for another reason you have to be home with them for a day or two.
11. Who prepares the meals for the children in the home?
12. How many meals a day do they have in the home?
13. What kind of meals do the children have for breakfast?
14. Who prepares the breakfast?
15. Who prepares lunch?
16. Who prepares dinner?
17. What kind of meals do you have for lunch and dinner?
